### **Background Investigation Unit (BIU)**

State-based Background Check Checklist

Due to Federal requirements, applicants who have lived outside of Colorado in the past five years are required to provide the following three background checks for <u>each</u> state they have lived in 1.) State Criminal History Check, 2.) State Sex Offender Registry Check, and 3.) State Child Abuse and Neglect Registry Check. However, a State Criminal History Check will not be required for states participating in the National Fingerprint File (NFF) Program. Currently, there are nineteen (19) states, besides Colorado, that participate in the NFF: Florida, Georgia, Hawaii, Idaho, Iowa, Kansas, Maryland, Minnesota, Missouri, Montana, North Carolina, New Jersey, New York, Ohio, Oklahoma, Oregon, Tennessee, West Virginia, and Wyoming. For <u>all</u> other previous states of residence, criminal history checks <u>must</u> be requested. A <u>complete</u> copy of each background check response <u>must</u> be retained in the employee's file on-site at the employment location. Also, another full set <u>must</u> be sent to the Colorado Department of Human Services (CDHS) Office of Early Childhood (OEC) Background Investigation Unit (BIU) to be reviewed for a determination of eligibility. Once the files are reviewed, the BIU will send the facility a letter regarding the applicant's eligibility status, whether the applicant is approved or not.

Please only send the OEC BIU your results once all *THREE* required background checks are completed for *ALL* states you have lived in over the previous five years from your hire date.

#### **Before Getting Started**

The form MUST be typed; handwritten checklists will not be accepted and will be returned.

- Information on how to complete each of these checks can be found on the state website from which
  you are requesting the background check. Each state's child care background check contacts may be
  found via this link.
- You must obtain <u>all</u> required background checks from <u>every state</u> you lived in in the past five years before sending this checklist to the BIU. If your state background check package does not include each of the three required background check responses from every state you have lived in over the past five years, your request will not be processed, and the materials will be returned.
- This request checklist generates ONE Results Letter. Results from this request are released to the person/agency/facility requesting the background check, NOT to the person being checked.
- BIU's review of all the submitted materials for state-based checks may take up to 25 days from receipt, so please plan accordingly. Requests are processed in the order they are received.
- The form must be typed; handwritten forms will be returned. If you have questions, please call the OEC's Background Investigation Unit at 303.866.5043. This is a monitored voicemail line; calls are returned within two business days. You may also email us at cdhs\_oec\_cbc\_biu@state.co.us.
